Access to district technologies is a privilege and may be revoked at any time for inappropriate behavior or conduct not in accordance with the District Technology Acceptable Use and Safety Policy.

Although issued to the student, the iPad or Chromebook is and remains the property of South Washington County Schools. It may be reviewed and revoked at any time. The student should have NO expectation of privacy regarding content on the iPad or Chromebook. District devices can only be activated with a valid District 833 username and password.

If a student fails to return the device and accessories (*iPad case and charging cords*) at the end of the school year or upon termination of enrollment from the issuing school, that student or his/her parent/guardian will be billed for the cost to replace the items not returned. Failure to comply with this requirement will result in a theft report being filed with the police department.
