Woodbury

**REFERENCE TO POLICY/STATUTE:** 701 School District Budget

#### A. PURPOSE OF REPORT

- a. During the summer of 2022 the City of Woodbury is constructing a new roundabout at the intersection of Lake Road and Pioneer Drive, directly adjacent to Lake Middle School.
- b. During this construction the city will require access for staging, utilities, and construction activities on the northern and western perimeters of ISD 833's property.
- c. The City of Woodbury requests a MOU for a temporary easement to ISD 833's property to conduct construction and excavation activities.
- d. There are no anticipated impacts to student occupied areas.

#### B. RECOMMENDATION

 a. Administration recommends approval of the MOU between ISD 833 and the City of Woodbury.



## RIGHT OF ENTRY AND WAIVER OF TRESPASS

Ind. The purpose of the Agreement is to allow construction at the earliest possible time, and the above-named record owners(s) specifically reserve(s) the right to make all claims necessary for damages which may be incurred as a result of the construction; and it may be necessary that the determination of such damages would be made by means of the necessary eminent domain proceedings. The above-named record owner(s) expressly waive(s) any claims of trespass which he/she/they/it may otherwise have over and across the property above-described by the City of Woodbury.
